Workers Comp. & Soc. Sec. Disability Law Firm Assists UUP members

If any worker has a work-related accident and gets medical treatment, she or he will be eligible for workers' compensation. You Do Not have to lose time from work to have a workers' compensation claim. Also, spending years at work using a computer may have caused carpal tunnel syndrome making you eligible for workers' compensation. Working for years lifting and moving hospital patients, working in awkward positions or doing the same job again and again may also make you eligible for workers' compensation due to a repetitive injury, such as a back injury.

Most importantly, workers' compensation does not automatically kick in when you report an injury to your employer. There is a claim form you must fill out and send to the New York State Workers' Compensation Board. Unfortunately, this claim form (called a C-3 form) is not available from your employer. As a member benefit, UUP has an alliance with a statewide law firm – Fine, Olin & Anderman, LLP (FOA) – to represent UUP bargaining unit members for Workers' Compensation and Social Security disability claims. This union-friendly law firm – which concentrates on Workers' Compensation and Social Security disability – will help you file the claim, represent you at hearings and answer your questions.

Call the law firm of **Fine, Olin & Anderman, LLP** at (866) FOA-4-UUP if you have been injured on the job. Be sure to identify yourself as a UUP member. There is No out-of-pocket cost to the UUP member.
