WHEREAS, The Student Association of SUNY at Oswego looks forward to future constructive involvement with the BPOE, therefore

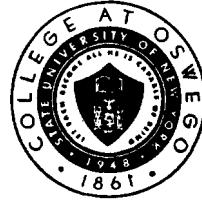

Be it resolved by SUNY Oswego that coke is already "it" and that its flavor should not be tampered with.

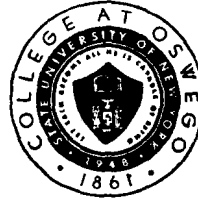

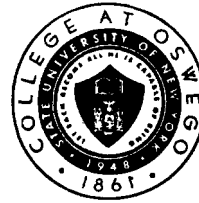

WHEREAS, Auxiliary Services is charging \$.10 for a glass of water in the cafeteria, therefore

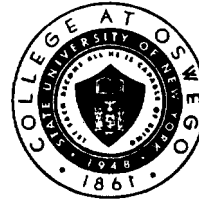

Be it resolved that the Student Association at SUNY College at Oswego supports these efforts in Alcohol Education and encourages students to participate in activities scheduled.

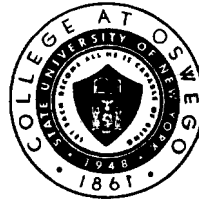

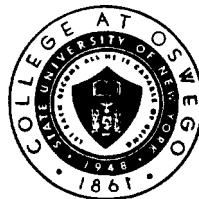

- WHEREAS, During the 1985 legislative session Member of Assembly Robert J. Connor introduced A 2168 which would amend the general obligations law and the public housing law in relation to use of plain language and lease model provisions of rights in agreements residential rental, and
- WHEREAS, The New York State Assembly passed this legislation which would mandate that all residential leases be written in plain and simple language, and to include a statement of rights and responsibilities of tenants and landlords to insure that tenants are aware of their rights under law, and
- WHEREAS, The New York State Senate failed to act on this measure, and
- WHEREAS, Many students sign leases that are filled with language that they do not understand, and
- WHEREAS, This legislation would help student renters in understanding their leases since the lease would have to be written in plain and everyday language, and
- WHEREAS, Assemblymember Connor has stated his intention to re-introduce this legislation during the 1986 session, therefore

Be it resolved that the Student Association Senate of the State University of New York College at Oswego supports the efforts of Assemblymember Connor in getting Plain Language Lease Legislation Passed and urges area legislators to support this effort, and

Be it further resolved that the Student Association urges the New York State Senate to act on Plain Language Lease Legislation during the 1986 legislative session.

Resolution 13

- WHEREAS, Legislation has been introduced by Senator Frank Padavan in the New York State Senate to amend the real property law in relation to the duty of the landlord to provide a written receipt to a tenant, and
- WHEREAS, The purpose of the Padavan bill (s-1762) is to require a landlord to give a written receipt to a tenant upon payment of rent by personal check, and
- WHEREAS, The New York State Assembly recently passed A 2456 which is the same as S 1762, and
- WHEREAS, Presently the law requires landlords to provide receipts when rent is paid through any means but personal check, and
- WHEREAS, This legislation is necessary because landlords, in some instances, have refused to issue a receipt when rent is paid, thus tenants are unable to prove payment; and
- WHEREAS, Returned - personal checks can be used as receipts, but until the checks are cancelled and returned, the tenant is at a loss to prove payment, and
- WHEREAS, Many student tenants are faced with the problem of not having proof that they have paid their rent until they receive their cancelled checks, causing a dispute with their landlord, therefore

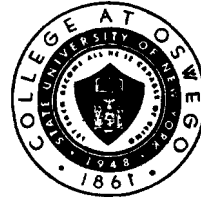

WHEREAS, Oswego opens its doors to the public for a full day of discussions, tours and exploration, and

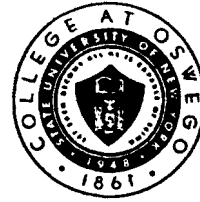
WHEREAS, Success of this year's 9th Annual College Open House will result in improved overall enrollment for the 1986-1987 incoming class, therefore
