 - A. Plaintiff calls and questions his witnesses. When finished with each witness, the defense may ask questions. Court may ask questions.
 - B. Defense calls and questions his witness. When firsted with each witness, the plaintiff may ask questions. Court may ask questions.
- V. Recapitulation
 - A. Plaintiff Summarizes.
 - B. Defence Summarizes.
- VI. Court Deliberates
- VII. Court reconvienes for verdict of the case with both the Plaintiff and the defence present.

- III. If court action results in the loss of the privileges of operating and parking a car on the Oswego campus. The student will be issued a non-registration violation, which is a \$15 fine, if his car is ticketed again on this campus.
 - IV. This bill shall become effective at the beginning of the Fall Semester of 1970.
