The following policy, procedure, and schedule be implemented for the operation and execution of the Student Association all-campus referendum.

I. Schedule

a. Nov. 9-10, the referendum will be held in the following places:

1. All dining halls - from 11:00 to 1:00 P.M., and from 5:00 to 7:00 P.M.

2. Hewitt Union Lobby (counter area)-from 9:00AM to 5:00PM.

b. Ballots will be counted beginning at 7:00PM on Nov. 10. Results will be announced immediately upon availability over WOCR and by way of poster in Hewitt Union Lobby, also in the next edition of the Oswegonian.

II. Communications

a. Senators will announce policy, procedure, and schedule in their respective living areas.

b. Public Service announcements on area radio stations.

c. One full-page advertisement in the Oswegonian.

d. Posters in all dining halls and Hewitt Union.

III. Method of Control

a. On campus residents will vote in the dining hall to which they are assigned. Student Association I.D.'s or a paid receipt with some form of identification will be checked

against a master occupancy list as certified by the dorm director.

- b. Off Campus residents will vote in the Hewitt Union lobby. Student Association I.D.'s or a paid receipt with some form of identification will be checked against a list of those who reside off campus.
- c. Discrepancies in the balloting from a particular area will invalidate the ballots from that area, but not the entire referendum.

- IV. The Senate shall designate a Referendum Chairman and a Supervisor for each area and for Hewitt Union. That person shall be responsible for recruiting poll watchers from the student body.

Poll Watchers

- a. No stipends will be paid in those areas where the balloting discrepancies take place, if such discrepancies are proven before the Supreme Court.
- b. Failure of Referendum Supervisors to prevent discrepancies may also be cause for reduction of stipends.

- V. The Referendum Committee shall consist of the Referendum Chairman and six referendum supervisors.

The Committee is responsible for the proper conduct of the counting of the ballots, and the publication to the student body.

VI. Responsibility

- a. The members of the Referendum Committee shall be legally responsible for the proper execution of the foregoing schedule, policy and procedures. The Referendum Committee must rule appropriateness of campaign activities in the polling building commensory with the policies described by the appropriate directors of the polling building.
- b. The persons staffing the polling place shall be legally responsible for the proper operation and execution of the balloting themselves during the following period of time:

Hewitt Union- Nov. 9-10. 9:00AM to 5:00 PM.

Dining Halls- Nov. 9-10, 11:00 to 1:00PM, and 5:00 to 7:00PM.

I. Schedule

- A. October 26, 1971, 9:00 A.M. to 4:30 P.M. petitions be available at SA office room 216 Hewitt Union and dormitory desks.
- B. November 2, 1971, 4:30 P.M. all petitions must be turned in at SA office before that time.
- C. November 2, 1971, 1:00 P.M. an official slate of candidates will be posted in lobby of Hewitt Union and at SA office.
- D. October 19, through November 8, midnight, campaigning may occur.
- E. November 9-10, 1971, elections will be held in the following place at the time indicated: 1. Dining halls 11A.M. to 1:00 P.M. and 5:00 P.M. to 7:00 P.M. 2. Hewitt Union Lobby 9:00 A.M. to 5:00 P.M.
- F. November 10, 1971, 7:00 P.M. until finished counting of ballots in Hewitt Union only complete results will be announced for each position as the counting is finished. Results will be announced immediately upon availability over WOOR and by way of poster in Hewitt Union Lobby. Also in the next edition of the Oswegonian.
- G. November 16, 1971 Senate Meeting request approval of election.

III. The senate shall approve of elections supervisors for each polling area.

A. No stipends will be paid in those living centers where the voting discrepancies take place in the judgement of the election committee.

B. No stipends will be paid in addition to the ones already made by the Referendum Committee to the Referendum Committee for supervisors and chairman. The duties of the election committee will be assumed by the Referendum Committee.

IV. Method of Control

A. On campus residents will vote in their dining hall in which they are assigned. Student I.D. or other I.D. plus paid receipt will be checked off against a major occupancy list as certified by a dorm director.

B. Off campus residents will vote in Hewitt Union lobby. SA I.D. will be used or paid receipt plus other I.D. and names checked off master list (Greeks will vote only for Greeks).

C. All expenditures of monies regardless of source must be registered in writing with the Election Committee in SA office.

D. The person or persons who is in control of that election poll, shall remove all candidates posters, pictures, flyers, etc. by Nov. 9, 1971 at 9:00AM within: 1. dining halls 2. Hewitt Union entire lobby area from stair west to entrance.

E. There will be no loitering of candidates within 50 feet of the polling area.

F. A candidate may not work at the polling booths.

V. Enumeration

A. Only those Senate seats that are vacant shall be filled by election.
