Introduced by Paul Lukasiewicz

Be it enacted by the Student Association Senate of the State University of New York, College of Arts and Sciences at Oswego that:

1. The College Vice President for Student Affairs be requested to appoint a committee of nine people.
2. The name of this committee shall be the Who's Who Selection Committee.
3. The Committee shall consist of the following representatives:
 - a. 5 students selected at large
 - b. 2 Faculty members one from the Professional Studies Division.
 - c. 1 Administrator non-teaching professional.
 - d. 1 Staff member selected from the classified services
4. This Committee shall select, from those students nominated, the representatives from this college to Who's Who in American Colleges & Universities.
5. Once the entire Committee has been appointed, they shall select from their members a chairman and establish such procedures as they will deem necessary to fulfill section 4 of the Act.
6. The Committee shall perpetuate itself in the following way:
 - a. Each member shall propose a successor for the following academic year.
 - b. The Committee shall either approve or reject the nominee.
 - c. In the event a nominee is rejected the person on the Committee, who nominated the nominee, shall repeat the procedure described above.

7. The Committee shall be appointed in May and begin serving the following September.
8. The term of the members shall be one academic year, except for the initial committee which shall serve two years.
9. No person is eligible to serve on the Committee more than one year in three.

Be it enacted by the Student Association Senate of the State University of New York, College of Arts and Sciences at Oswego that:

The Student Association Program Policy Board be created to administer the Student Association programming for the areas of cultural, popular, and impromptu events. This board shall be advised by a Hewitt Union staff member and shall be composed of no more than twelve members. Among those members shall be one member of the Senate Finance Committee elected by that body, one member of the Budget Council elected by that body, one Senator elected by that body, and one member of the Executive Staff. Original four members plus the advisor shall appoint remaining members to the board with Senate approval. This committee shall give a written report to the Senate each week concerning the programming which it is considering and events already programmed.



Be it enacted by the Student Association Senate of the State University of New York, College of Arts and Sciences at Oswego that:

Any officially recognized body of students representing a living center that is holding an officially recognized living center election, can at the time of that election, hold an election to fill any vacant senate seat representing that living center. This may be done before Student Association's fall referendum and must be done under the supervision of the Senate Election Committee. All other vacant seats shall be filled by election at the time of the S.A. fall referendum and shall also be under the supervision of the Senate Election Committee. The definition and the terms for an officially recognized body and/or election shall be defined by the Senate Election Committee. Recognition of these bodies and elections shall also be done by the Senate Election Committee.
