



Cosigning Inbox Orders

June 17, 2009



Administrative Policy IM 0063

- Defines the circumstances where verbal or phone orders can be used.
- Only in emergent situations where therapeutic intervention is immediately necessary.
- Accepted by “attending MD only” in the newborn nursery and OB department.
- May only be given to a licensed RN or pharmacist.
- Never on pediatric units.
- Signature must occur within 24 hours.
- Failing to sign may be referred to the Medical Quality Assurance Committee.



Workflow Process

- Change in workflow to include a review of your inbox daily is required.
- Surgeons or interventionalists will need to review post case to sign all orders entered during procedures.
 - The pathology specimens, blood gases and med orders you ask for during a case will need your co-signature!

Here is the example we built to show you about inbox co-signature:

Two orders were placed by the nurse on the screen above, aspirin and Coreg

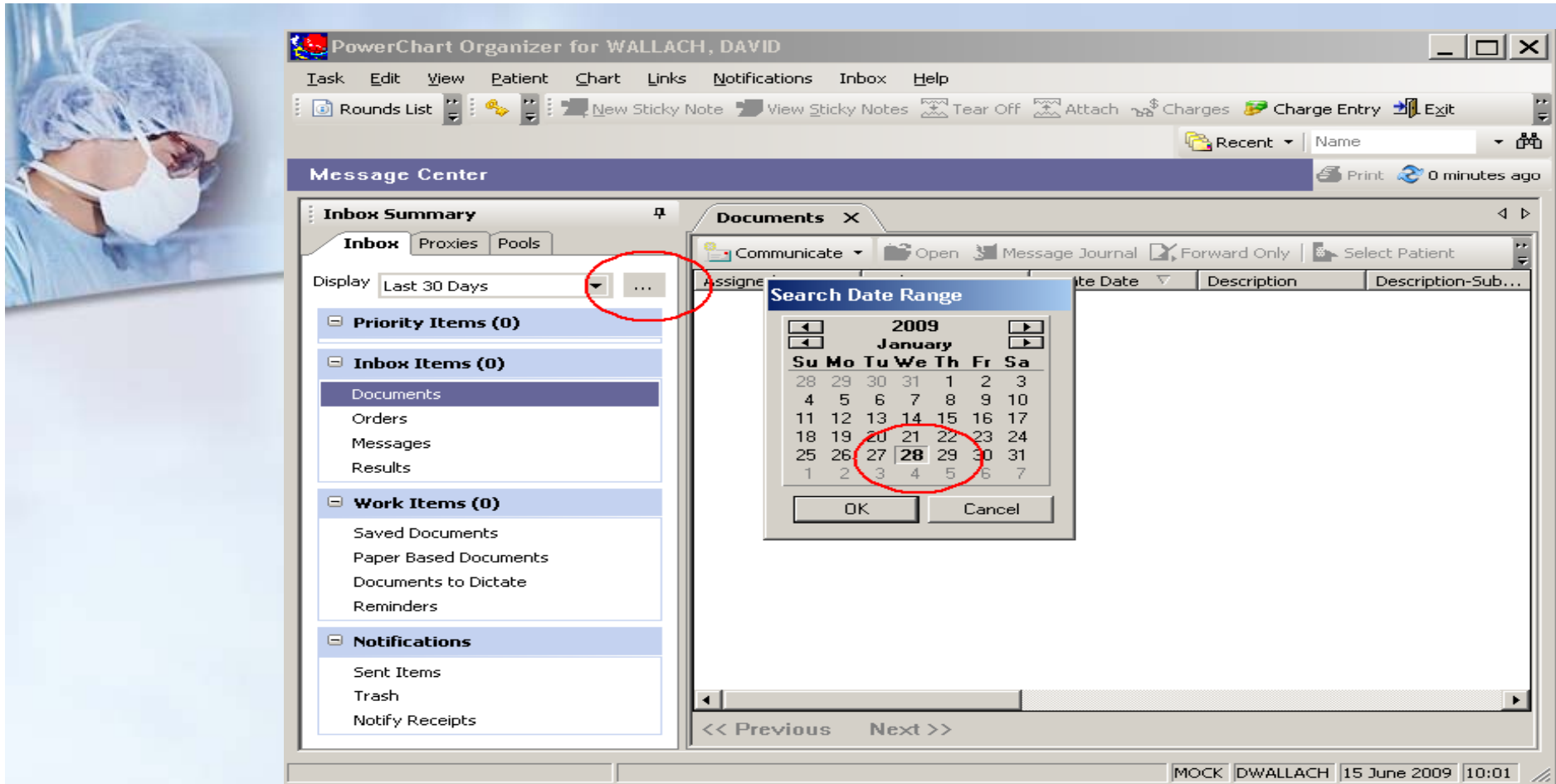
You can tell right from the orders screen these orders need a cosignature because there is a caduceus icon, which denotes an co-signature is required.

Any provider can highlight , right click and sign the verbal order right from this screen.

Why would someone sign from the orders screen?

The most common scenario would be a covering physician in a practice would sign for the partner who gave a verbal order. By policy you CAN sign that order.

Now let's go see the inbox.....next slide



To “catch up” with unsigned orders you must change the search range of the inbox. The normal default is set for the last 30 days. Several people may have orders to sign as far back as Jan 28 when CPOE went live. To increase this search range please click the elipsys button and click on January 28, 2009. Now let’s go to the next slide and pull the orders for approval into view.....next slide.....

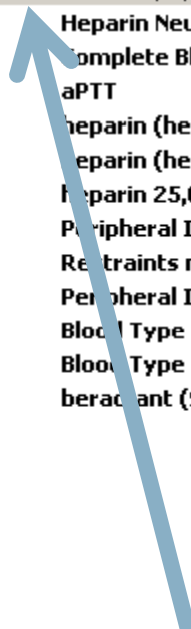
