New Actuarial Tables for retiree health insurance to apply Sept. 1st, 2013

We just received word from the Department of Civil Service that the new actuarial tables used to calculate the monthly credit toward the cost of retiree health insurance from UUP members' unused sick leave (up to 200 days) will be applied to persons **retiring on or after September 1, 2013.**

It is our understanding that SUNY Human Resources Departments have not been officially informed of this implementation date and that Civil Service is working to get the information out to SUNY Health Benefits Administrators as soon as possible.

Please note that members must verify all information pertaining to retirement through their Human Resources Departments.

UUP's Tentative Agreement language indicated that the new actuarial tables would take effect "no less than 30 days" after ratification. The September 1, 2013 implementation date was set by the Department of Civil Service.
