## **Revisions to the Department of Recreation and Leisure Studies Concentration in Tourism Management**

---

### ***Rationale***

The Department of Recreation and Leisure Studies conducted a review during spring 2015 into fall 2016 semesters on the existing concentration in Tourism Management. This was the first review since the concentration was implemented in the year 2009. These revisions serve multiple purposes:

1. They represent where the field is today.
2. They are reflective of our own internal assessment of learning outcomes and national accreditation standards.
3. As a result of recent changes by our accrediting organization (COAPRT), recreation and leisure programs now have more flexibility regarding curricula content.

### ***Overview of changes:***

- Updated language in course names (REL 395 and REL 440)
- Requires students to complete the same five courses vs the current model of three required courses and choice of two electives.
- Removal of elective course, REL 435, Resort and Hotel Operations (3 credits)
- Total credits for the Tourism Management Concentration remain at 15 credits.
