RESOLUTION ON BROCKPORT SCHOLARS' DAY

Whereas the experiment with Brockport Scholars '84 was such a success,
and whereas many people felt that their ability to participate in the event
was severely curtailed by obligations to scheduled classes,

and whereas the College Union facilities will not be able to accommodate a
significantly larger audience,

therefore, be it resolved:

that Scholars' Day should become an annual event;

that every year the Academic Calendar should set aside one entire day
for this and associated events;

that the facilities of Edwards Hall be available for Scholars' Day;

that Scholars' Day be run and funded out of the Office of the Academic
Vice President; and

that the Scholars' Day Planning Committee consist of the Academic Vice
President's designee, three faculty, and a representative of Brockport
Student Government.
