Just say NO to unwanted Credit Card offers

AARP had an article if you want to block "preapproved" credit card offers. Consider **opting out** by calling toll-free 1-888-567-8688 or visit <http://www.optoutprescreen.com> Both are operated by the 3 major credit bureaus and are **Free of Charge**. You will have to provide your name, address & social security #, which will only be used to process your request to opt out according to the Federal Trade Commission. If you have joint credit with a partner, you both have to opt out. This program lasts 5 years unless you follow up with a written request to make it permanent. You can change your mind and want a new credit card, so you can reverse the procedure and opt-in.

New Mileage Reimbursement rate for 2008

The IRS has announced the mileage rate for expense vouchers will go up from present 48.5 cents per mile to **50.5 cents per mile on January 1st, 2008**. Please make a note of this if you charge for vehicle usage.
