

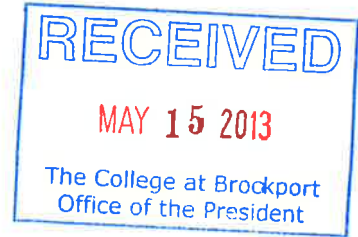

Delta College Foreign Language Reduction Proposal

Summary

The Delta College faculty proposes to reduce our Foreign Language requirement from essentially three semesters to credit for Foreign Language 111 for our students seeking a Bachelor of Science degree. Delta College students seeking Bachelor of Arts degrees would still be required by their degree programs to complete one foreign language to the 212 level.

Rationale:

First, The College at Brockport has reduced its Foreign Language requirement for General Education to one semester (credit for Foreign Language 111) for students seeking Bachelor of Science degrees; we would like to have our requirement be the same as the College's General Education requirement, since Delta College is principally a general education program. We do not question the value of foreign language acquisition, but follow the College's approach of embedding requirements within the degree program, major, or certification rather than in the General Education Program.

Second, our student demographic has changed since the program was reconfigured in 1995. Then the approximately thirty Delta College students per cohort all sought Bachelor of Arts degrees, requiring them to complete four semesters of one foreign language. Delta College provided much of that instruction through its own Language Tutorials. Now most of our sixty students per cohort seek Bachelor of Science degrees in virtually every major offered at the College, and we do not offer foreign language instruction. The current foreign language requirement is a vestige of the initial BA focus of the program and does not adequately reflect the needs of our current students to complete complex and course-intensive majors in a timely fashion. With our foreign language requirement set at 9 credits, the Delta College Program requires 65 credits; See Table 1.

With the proposed change, the Delta College curriculum would be reduced by 6 credits to a total of 59, but it would still require many more credit hours than the regular general education program. See Table

2. It should be noted that the Delta College Program offers an integrated and interdisciplinary approach to the liberal arts and sciences, so the “Course Equivalents” listed on Tables 2 and 3 are approximate.

The College’s General Education Program and Delta College Program with three exceptions largely match each other in terms of credit hours required. The most notable difference between Delta College’s requirements and those of the College at Brockport is the 23 credits of Integrative Learning Seminars and Experiences that Delta College requires of its students, but is not part of the College’s requirements. The Integrative Learning Seminars provide instruction and experience in subjects not required by Brockport’s General Education Program and prepare students to pursue the required internships. The Integrative Learning Experiences are fulfilled through internships or study abroad; these activities may be pursued by students outside of the Delta College Program, but are not required by Brockport’s General Education Program. These additional credits reflect our mission to prepare students for life after college through internship preparation, internships, and study abroad. The next largest difference is the 9 credits of Foreign Language study or its equivalent that we currently require, and the smallest is our 2-credit Educational Mentor Tutorial that replaces 4 credits in the regular general education program. As a result, there are 21 credits within the Delta College courses alone that are over and beyond what is required by the College, plus 6 credits of foreign language study. Reducing the foreign language requirement to 3 credits would bring our credit requirements down to

59, which is still considerably higher than the College's 38-41 credits, but more manageable for our students. Without the required internships, the credit hours are almost the same, with Delta College's at 43. See Table 3.

Potential Effects on Other Departments

The Department of Modern Languages and Literature would feel some effects from this change as fewer Delta College students would be taking foreign language courses above the 111 level. As a result, this proposed change would not require additional resources. It could actually allow all students at Brockport who need to take foreign language coursework to do so in a more timely fashion. **The Department of Modern Languages and Literature has reviewed this proposal. Although they do not support the reduction of the Foreign Language requirement, they do not believe it is their prerogative to determine our curriculum.** It should be noted that some Delta College students do seek Bachelor of Arts degrees, whose foreign language requirements would remain unchanged; these students would continue to take foreign language coursework above the 111 level.
