The Department of Chemistry is in the process of implementing a name change to the Department of Chemistry and Biochemistry. The Department voted unanimously in favor of this change based on the following considerations:

- 1) The Department now offers majors in both Chemistry and Biochemistry. This name change will help to publicize and make more visible the new Biochemistry major (approved 2009)
- 2) This name change will enable prospective students to be better aware of which Department to contact regarding questions about the Biochemistry major
- 3) This is not a unique or unusual designation as many Departments that offer both majors have adopted the name "Department of Chemistry and Biochemistry"

No changes are to be made to the curriculum of any degree program. Course designations will continue to be CHM xxx.
